Occupational Health Nurses Spirometry Training

Shortly before lockdown restrictions were announced in August, Occupational Health Nurses from around the Bay of Plenty were in Waihi at OceanaGold's Education Centre for a course on spirometry. Occupational Health Nurses work to maintain and improve the health and safety of employees within the workplace, across numerous health disciplines. Nurses provide a wide range of services to multiple industries, from healthy heart and skin cancer awareness programs through to muscular-skeletal injury prevention, drug and alcohol screening, and vaccinations.

Our Occupational Health Nurse Marilyn Rooks explained that spirometry is a common test used to assess how well a person's lungs work.

"A spirometer measures how much air a person inhales, how much is exhaled, and how quickly the air is exhaled."

Marilyn says that spirometry is used to diagnose asthma, chronic obstructive pulmonary disease, and a range of other conditions that affect breathing.

"A spirometer can be used in an office by a trained person, and so is a really useful tool for companies such as OceanaGold as part of the regular ongoing assessment of the health of our staff."

13 Occupational Health Nurses attended the course which covered official standards, interpreting results, and quality control. Part of the day included a tour of the mine. Marilyn says, "It was a chance for all of the nurses to reflect on how a day would look for Laura Burke, the Martha Mine Nurse back in the late 1800s."

CORRENSEN & PROJECT MARTHA PUBLIC COMMUNITY MEETING

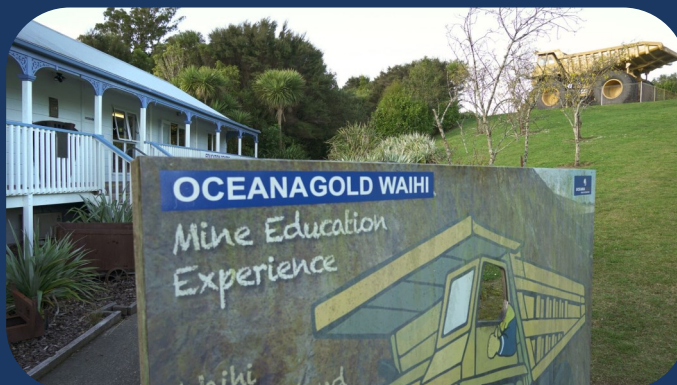

We will confirm a new date and time when possible through our regular channels. Apologies for the inconvenience and we look forward to catching up with the local community when it is safe to do so.

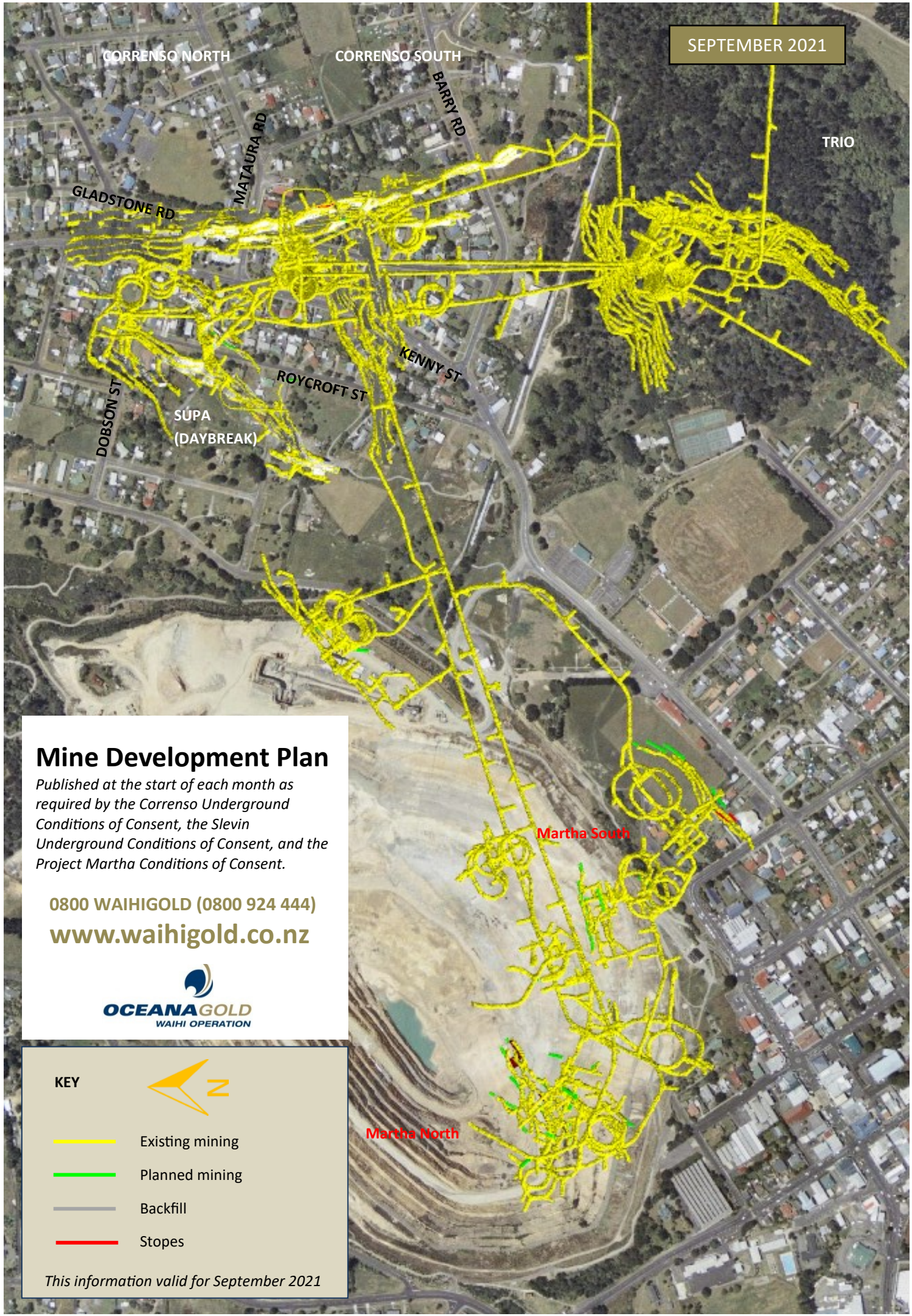
