

## Ask the Experts about... Air Quality – Waihi North Project

If the Waihi North Project is approved, we expect to monitor and manage air quality in accordance with an Air Quality Management Plan that would need to be approved by Waikato Regional Council. The Waihi Operation has been effectively monitoring inhalable gasses or particulates to meet strict air quality consent limits in the vicinity of Waihi operations since 1982.

On Thursday the 25th of May, between 9:00am and 3:00 pm, Richard Chilton from Tonkin and Taylor will be available in our Project Information Office at 86 Seddon Street, Waihi, to answer any questions you might have on air quality relating to the Waihi North Project.
