## Public Hearing on the Martha Mineral Zone

A hearing to consider and make recommendations on what is being proposed by OceanaGold via Proposed Plan Change 6, and requests made in submissions or further submissions, is scheduled to take place from the 10th to the 12th of December at the Presbyterian Community Hall, 76 Moresby Avenue, Waihi.

At the hearing, which will be before an independent Hearing Committee made up of four commissioners, submitters on Proposed Plan Change 6 are able to present evidence to support the points made in their submission/s. Members of the public are free to attend to hear the submissions of various parties.

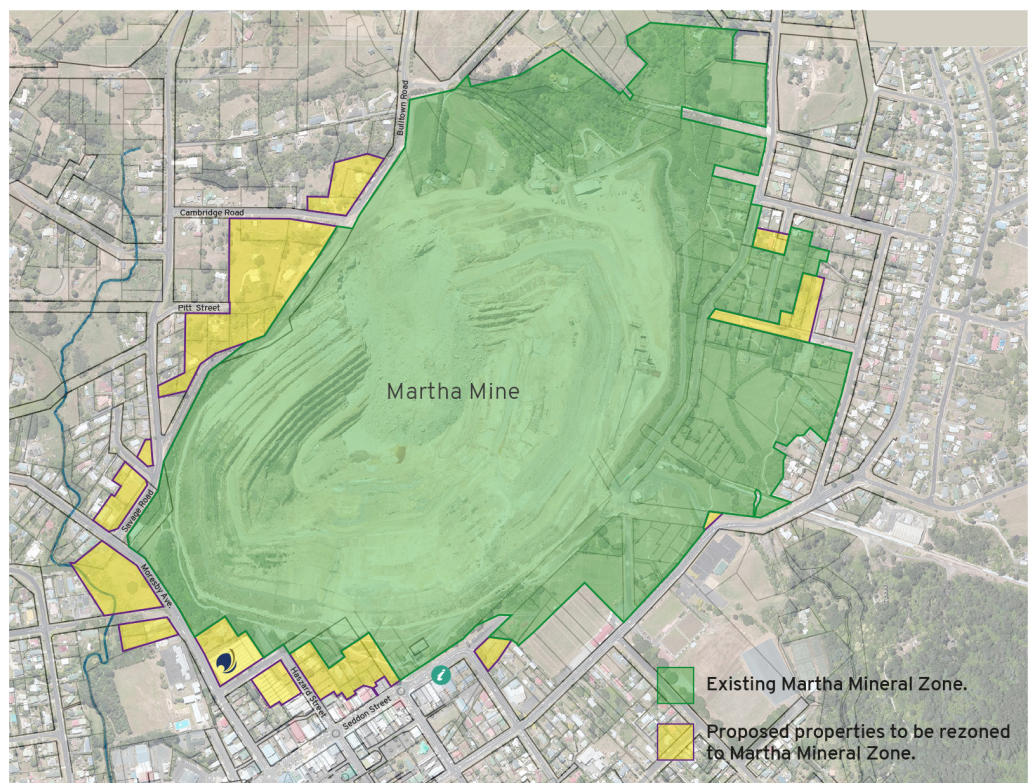
The proposed expansion of the Martha Pit, as part of the Martha Open Pit Project, would first require a change to the District Plan to increase the boundary to include all the land parcels necessary to support the expansion (this is inclusive of areas required for rehabilitation).

No privately owned land will be

rezoned as part of the plan change application.

**A change to the Martha Mineral Zone doesn't mean we can mine.** Any mining activity is controlled by the Resource Management Act and resource consents would still need to be sought should the plan change be approved.
