



## Correnso & Project Martha Community Meeting - Sept. 11th

Our next Correnso and Project Martha Community Meeting will be held on Thursday the 11th of September from 5:30 to 7:30 pm.

This public meeting is designed to provide an update about works in the existing Correnso and Project Martha (including Rex) mining areas undertaken since the previous meeting.

The meeting will be held in the OceanaGold Education Centre on the corner of Moresby Avenue and Savage Road. This meeting is open to the public and all are welcome. For queries on all other current or proposed projects, please visit or call the Project Information Office.

## Blast Times in the Martha and Correnso areas

Our underground mining consents set times when we must make best endeavours to carry out blasting, known as 'blast windows'. Main production (stope) blasts are usually:

- Correnso: 1:00–2:00pm
- Project Martha: 1:30–2:30pm

If blasting occurs in both areas, we aim to fire between 1:30–2:00pm, when the windows overlap.

The other windows, where we typically blast

'development' shots with lower levels of vibration, are 7–8am and 7–8pm.

With activity in Correnso reducing, most future blasts are expected in Project Martha, using the 1:30–2:30pm window.

## Trenchworks Beside State Highway 25

We're installing infrastructure to carry water, power and fibre optic cable between our Waihi Processing Plant at Baxter Road and company owned property at the end of Willows Road, just north of Waihi. These services will be essential for building the surface infrastructure associated with the Wharekirauponga Underground Mine – if we gain approval for the proposed Waihi North Project.

We've obtained the necessary approvals from Hauraki District Council, Waikato Regional Council, and the NZ Transport Agency to undertake this work, which is separate from our Fast-track approvals process for the Waihi North Project.

The pipes will be buried underground in road reserve along SH25 and Willows Road, or on OceanaGold land. We're working with our contractors to minimise disruption and will do our best to let you know of any delays ahead of time.
