

THE WAIHI NORTH PROJECT

The Waihi North Project was first announced in June 2021, with a resource consent application lodged a year later in June 2022. Since that time, we have been undertaking work to answer a Request for Information (RFI) that was subsequently received from the Hauraki District and Waikato Regional councils.

With the recent announcement of the Fast-track Approvals Bill by the New Zealand Government, OceanaGold has now decided to pause the existing RFI process for the Waihi North Project while we learn more about Fast-track.

The Waihi North Project signifies a long-term commitment to, and investment in, the wider region. If approved, the project will extend operations to 2037 and beyond, longer than any single previous
