WAIHI NORTH PROJECT UPDATE PANEL CONSIDERING OUR APPLICATION

In May 2025, the substantive application for our Waihi North Project was accepted into the Fast-track approvals process. An expert panel was then established to act as an independent decision-making body.

One of the Panel's first roles was to invite written comment from some people or groups as listed in the Fast-track Approvals Act 2024. Only the panel could invite comments on the application, and only those invited to comment may do so. As the applicant, OceanaGold had no control as to those who were or were not invited to comment.

The timeframes for invited individuals or groups to comment on Waihi North has now closed and replies to those comments from OceanaGold have been made and published on the Fast-track website.

WHAT HAPPENS NOW?

The Panel will now take time to review the information provided and decide how they wish to proceed. The panel may request further information or reports, or request or commission advice, to inform their decision. A hearing is not required, but the panel must consider whether to hold one.

Barring any suspensions to the process, the Panel's decision on the application is set as being due on the 18th of December 2025.
