TRENCHWORKS BESIDE SH25

Beginning in August, we'll be installing infrastructure to carry water, power, and fibre optic cable between our Waihi Processing Plant at Baxter Road and company-owned property at the end of Willows Road, just north of Waihi.

The pipes will be buried underground in road reserve along SH25 and Willows Road, or on OceanaGold land.

Works are expected to take approximately 12 months to complete, subject to weather conditions and other factors beyond our control.

HOW DOES THIS WORK INTEGRATE WITH THE PROPOSED WAIHI NORTH PROJECT?

We've obtained the necessary approvals from Hauraki District Council and Waikato Regional Council to do this work, separate from our Fast-track approvals process for the Waihi North Project.

This is a proactive step we've taken to ensure we're well positioned to start work, should the Waihi North Project be approved. We're working with our contractors to minimise disruption wherever we can.

WAIHI NORTH PROJECT UPDATE FAST-TRACK APPLICATION PANEL ESTABLISHED

OceanaGold is pleased to update that the independent expert panel for the Waihi North Project under the Fast-track approvals process has now been established by the Environmental Protection Authority (EPA) to assess the project.

The EPA say that the panel members were chosen for their combined expertise and experience in relation to law, planning and policy, te ao Māori and Māori development, Hauraki-specific mātauranga and tikanga, freshwater ecology, geotechnical engineering, and mining.

The next step in the process is for the panel to invite written comment from people or groups as listed in the Act. This is currently anticipated to be issued on the 28th of July.

Barring any suspensions to the process, the Expert Panel decision on the application has also been set as being due on the 18th of December 2025.
